OFFICIAL RULES "WOOF FM'S SPRING 2025 5K GIVEAWAY"

I. CONTEST

The ("Sponsor") of "WOOF FM'S Spring 2025 5K Giveaway" (the "Contest") will giveaway \$5000.00 ("Grand Prize") and additional "On-Air Qualifying Prizes" according to the terms and conditions of these rules. The Contest will run from April 14th, 2025 to May 30th, 2025. Radio broadcast station WOOF FM is owned by WOOF, Inc and is referred to in these rules as the ("Station").

II. SPONSOR

The Contest is sponsored by WOOF, Inc (the "Sponsor") that is the licensee of WOOF FM Dothan (the "Station").

III. ELIGIBILITY

All individuals that are 6 years of age* or older and residing in the "WOOF FM Designated Listening Area" consisting of these Counties:

AL: Barbour, Coffee, Covington, Crenshaw, Dale, Geneva, Henry, Houston, Pike.

GA: Calhoun, Clay, Decatur, Early, Miller, Quitman, Randolph, Seminole.

FL: Holmes, Jackson, Washington

All winners must provide complete and valid identification in order to claim a prize. Winners must be prepared to show 2 forms of identification.

*If the winner is a minor the legal guardian must accept the money on behalf of the minor. (if the winner is deceased, the executor of the estate must accept the money on behalf of the deceased.

Only one person may qualify per household in each of the "four ways to qualify".

IV. HOW TO QUALIFY

No Purchase Necessary. There are "four ways to qualify" for a chance to win the Grand Prize:

Our howl sound effect will not be played during a commercial or song.

You may obtain in person a cash card when we are out on location or at the WOOF FM studios during regular business hours, Monday through Friday 9a to 5p. Only one card per person for the duration of the contest. The cardholder is the person whose name and information is on the card. Anytime Monday through Sunday, 7am 7pm we may call out cash card numbers from those already distributed. If your cash card number matches exactly in order as given out on the air you have 10 minutes to call us back on our contest line to claim your "qualifying prize", a \$50 gas card and a plush baby woof wolf.

- 3) The third way to qualify is with the "WOOF FM Work Call". Login to 997wooffm.com and let us know where you work, when & why you listen, and how many co-workers you have in your office or on your shift. Include your full name and phone number then listen at work! If you hear your name on the radio at work, call us back within ten minutes at 1-800-239-9663 to claim your "qualifying prize", a \$50 gas card and a plush baby WOOF wolf.
- 4) The fourth way to qualify is stop by one of our specified "Out On Location" broadcasts and enter into a drawing to be drawn at the conclusion of the broadcast for a "qualifying prize" of a \$50 gas card and a plush baby woof wolf (We will notify winner. Presence not required). "Out On Location" site owners and each of their respective employees and immediate family members are ineligible to participate in the "qualifying prize drawing" but are allowed to obtain a cash card to participate in the overall Contest.

WOOF FM's 30-day contest rule does not apply. The Sponsor reserves the right to substitute any prize for cash or other similarly-valued consideration, however the Winner may not request any prize be substituted for Cash.

Sponsor reserves the right to change these rules at any time as it determines necessary in its sole discretion. Sponsor reserves the right to terminate the Contest if fraud, misconduct or technical failures destroy the integrity of the Contest, or for any other reason deemed reasonable by Sponsor.

IX. LIMITATIONS OF LIABILITY

All participants agree to release and hold harmless Sponsor and all of its respective affiliated companies and all of their respective directors, officers, employees, agents, legal counsel, and/or participating promotional partners from all losses, damages, penalties, claims, actions, suits, costs, and expenses of any kind whatsoever and any property damage, personal injury, or death to any participant or third person caused by or arising out of or in connection with participation in the Contest or with the use of any prize awarded.
